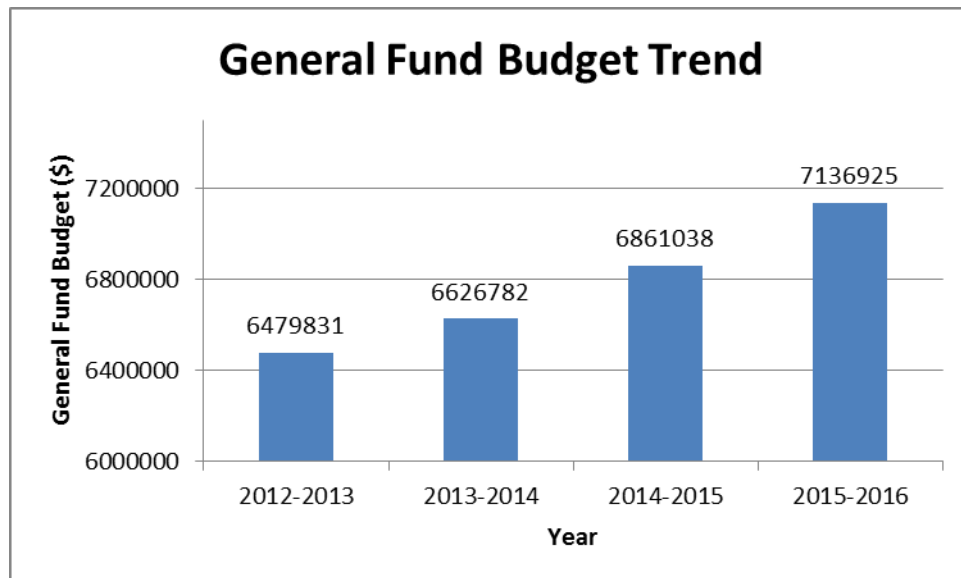

Fiscal Information

Weston County School District #7 obtains revenues to pay for its educational services from state and local taxes. This revenue provides the District with funding for the necessary instructional and operational resources to provide each student with equal opportunity to receive a proper education. An annual increase in expenditures directly correlates with the continued increase in educational expenses.



Consolidated Grant

The Consolidated Grant is an umbrella from which funding from the federal government is allocated to local school districts. The programs listed below have restrictions for use and are carefully monitored by the Wyoming Department of Education. Not all school districts get the same funding and the criteria for each program funding can vary. The following details the funds available for 2015-2016 School Year.

Highly Qualified Staff

NCLB legislation requires all teachers to be “highly qualified” within the area they are teaching. Parents are entitled to information regarding the qualifications of their child’s teachers. As of September of 2015, 100% of the Weston County School District #7 teachers who instruct in the following core areas are listed as Highly Qualified.

PAWS

Proficiency Assessments for Wyoming Students is the assessment system developed by the Wyoming Department of Education in cooperation with ETS. The assessment was developed to help meet the No Child Left Behind Act requirements.

Wyoming assesses students for the following standards:

Math - Skills for Number Operations, Geometry, Measurement, Algebra, Data Analysis, and Probability

Reading - Reading Functional Texts, Expository Texts, & Narrative Texts

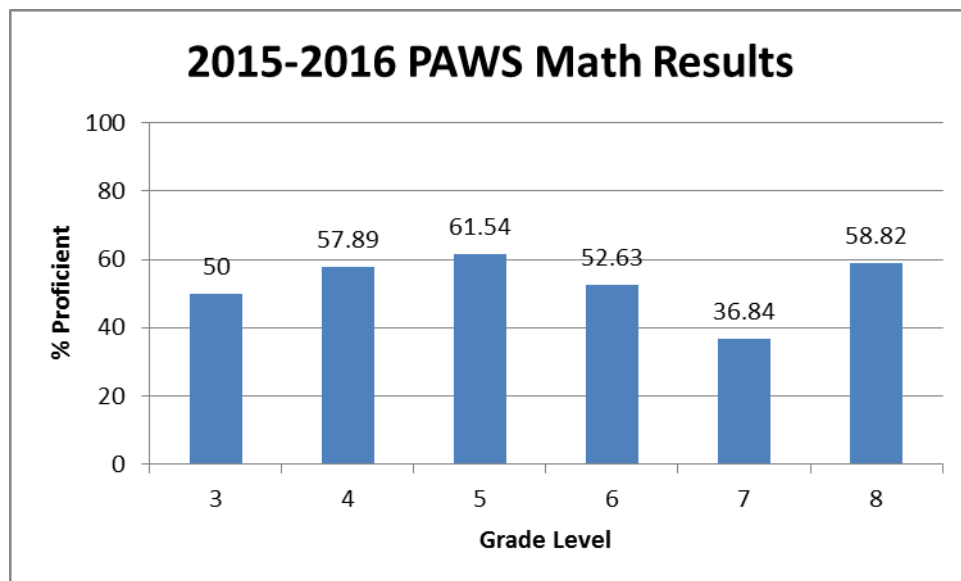
Science – Scientific Inquiry, Draw Conclusions, Scientific Investigation

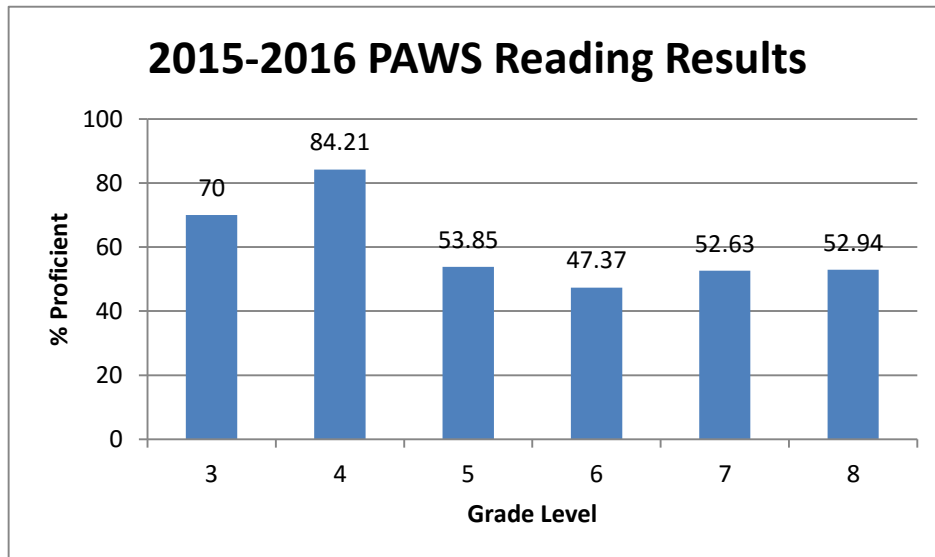
Program Data

ACT

Also known as the American College Testing program, the ACT is a required test of all junior level students at Upton High School. Once just used for college entrance, the assessment now provides valuable information with regard to the student level of mastery in the core subject areas.

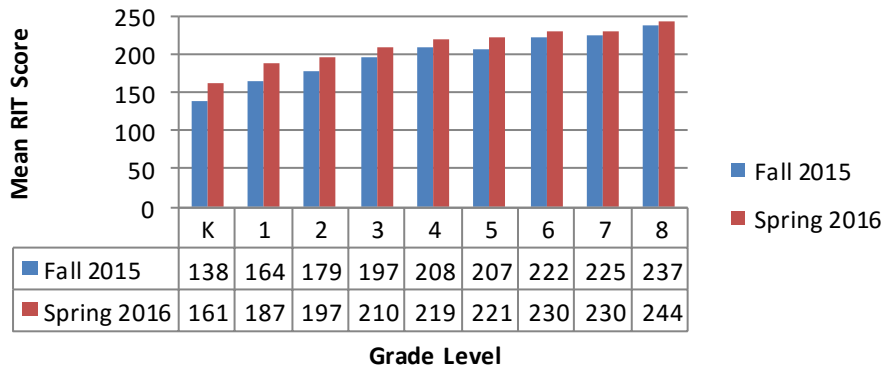

NWEA MAP

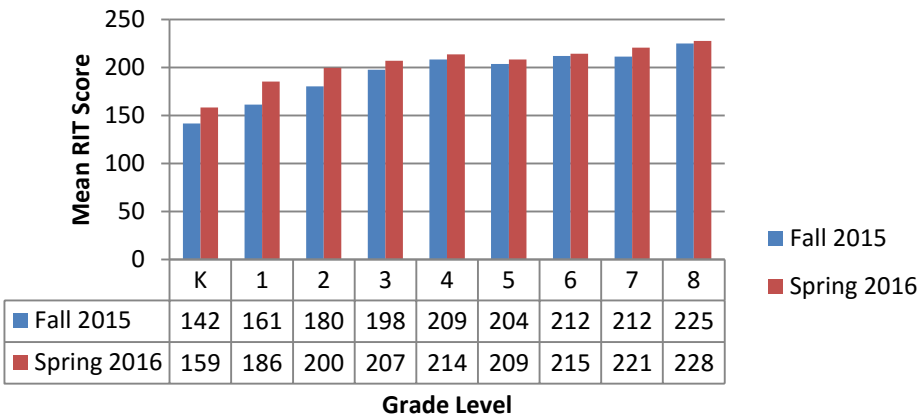

- Make data-driven decisions
